- Send advertisement proposals and carry out a follow up on these.
- To fulfil contractual commitments of any nature.

- Exchanging commercial and business information inherent to the business activities.
- Manage the purchase or contracting of goods and services.

- Verification of personal and work references of participants in selection processes.
